VACANCY CIRCULAR

Sub: Filling up three posts of Deputy Director (Dev.) [UR-1 and OBC-2] in Coconut Development Board, Kochi under direct recruitment.

It is proposed to fill up 3 (three) posts of Deputy Director (Dev.) in Level-11 of the Pay Matrix (Rs.67,700-2,08,700) [Pay band -3, Rs. 15600-39100 with Grade Pay Rs.6600 (pre-revised)] in Coconut Development Board, an autonomous organization under the Department of Agriculture, Cooperation and Farmers Welfare, Ministry of Agriculture and Farmers Welfare **on direct recruitment basis**. Out of the three posts, one is unreserved and two are the back log vacancies reserved for OBC.

Eligibility conditions :-

Educational and other qualifications

- (i) Post Graduate Degree in Horticulture / Agriculture/Plant Sciences (with working experience of plantation tree crops) from a recognized University or equivalent; and
- (ii) Seven years experience in a responsible capacity (out of which 5 years experience in a Group A post under the Central Government or equivalent) in agriculture development with particular reference to coconut crop.

Age limit : Not exceeding 45 years (Relaxable for Government servants and employees of the Coconut Development Board up to 5 years in accordance with the instructions / orders issued by the Central Government. The upper age limit is also relaxable for OBC candidates up to 3 years.)

Note:-The crucial date for determining the age-limit shall be the normal closing date for receipt of applications. (and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh division of Jammu and Kashmir State, Lahual and Spiti district and Pangi Sub Division of Chamba district of Himachal Pradesh, Andaman and Nicobar Islands or Lakshadweep.)



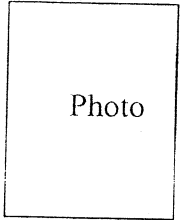
