- 5. Age Limit: The maximum age limit for appointment by deputation (istc) shall be not exceeding 56 (fifty six) years, as on the closing date of receipt of applications.
- 6. Method of Recruitment: By deputation (including short term contract)/ promotion.
- 7. Eligibility:

<u>Service</u>:- Officers under the Central Government or State Governments or Union Territories or Universities or recognised Research Institutions or Public Sector Undertakings or Semi Government or Autonomous or Statutory Organisations:

- (a) (i) holding analogous post on regular basis in the parent cadre or Department; or
- (ii) with five years' service in the grade rendered after appointment thereto on a regular basis in Pay Band -3 in the scale of pay of Rs. 15600-39100 with Grade Pay of Rs. 7600 or equivalent in the parent cadre or department; and
- (b) possessing the following educational qualifications and experience, namely:-

Essential:- (i) M.Sc. in Microbiology from a recognized University or Institute;

Or

M.Sc. in Botany with specialization in Plant Pathology or Microbiology or Mycology from a recognized University or Institute;

Or

M.Sc. in Agriculture with specialization in Soil Science or Agricultural Chemistry or Agronomy or Microbiology or Plant Pathology or Horticulture or Agricultural Extension from a recognized university or Institute; and

(ii) twelve years experience in the field of bio-fertilizer or fertilizer use or recycling of organic waste or quality control of organic manure or compost use, quality control of bio-fertilizers or bio-pesticides, organic farming promotion and Certification or Agricultural Extension with emphasis on organic farming promotion.

<u>Desirable</u>:- (1) Ph.D. in any of the subjects specified in the essential educational qualifications above from a recognized University or Institutes.

(2) Administrative experience of implementing developmental programmes in the field of fertilizers, compost, manure development, biofertilizers, biopesticides and organic farming.

Note:- Departmental officers holding the post of Regional Director in the Pay Band-3 in the scale of Rs. 15600-39100 plus Grade Pay of Rs. 7600/- with five years regular service shall also be considered along with outsiders and if they are selected for appointment, the post shall be deemed to have been filled by promotion.

8. <u>Place of posting</u>:- National Centre for Organic and Natural Farming (NCONF), Ghaziabad

Note-1:- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation including short-term contract. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note-2:- Period of deputation (including short-term contract) including period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central government shall ordinarily not exceed five years.

Note-3:- The maximum age limit for appointment by deputation including short-term contract shall be not exceeding fifty six years as on the closing date of receipt of applications.
