With the approval of the Competent Authority it is proposed to fill up one post of Chief Seed Analyst, two posts of Seed Technologist and one post of Administration Account Officer in the National Seed Research and Training Centre, Varanasi (Uttar Pradesh). The mode of recruitment, eligibility, educational qualifications, experience and other eligibility conditions for the posts are as under:

1. Chief Seed Analyst (One post):
