ADVERTISEMENT

Applications, in plain paper, are invited from the eligible Retired officers of State Government/Central Government organisations for engagement to the post of "Director of Horticulture & Soil Conservation, Tripura," on purely contractual basis. The details about the qualification & eligibility criteria for the post, terms & conditions may be seen in the Departmental website www.agri.tripura.gov.in.

[A] Eligibility criteria of the candidate applying for the aforesaid post would be as follows –

- a) Retired Government officers/candidates having at least 3(three) years experience as Director of Horticulture or equivalent posts.

OR


Retired officers of Central Govt. organizations, who were drawing salary in the equivalent pay Level 13 under the Pay Matrix of 7th CPC of Govt. of India.

- b) The candidate must have minimum qualification of M.Sc degree in Horticulture.
- c) Preference will be given to those candidates having Ph.D in Horticulture.
- d) The candidate should be physically fit and mentally alert and also below 65 years of age. The contractual service for such period not exceeding one year at a time may be considered, but he or she should not be continued beyond completion of the age of 65 years.

[B] Terms & conditions for the aforesaid post would be as follows –

- (a) The application in plain paper must reach the Directorate of Agriculture, Krishi Bhawan, Agartala-799001, Tripura (West) on all working days during the period w.e.f. 13th January, 2020 to 27th January, 2020.
- (b) If any Application is found incomplete or sent through e-mail or received after the cut off date will not be considered. Further the authority will not be responsible for any postal delay.
- (c) Self attested photocopies of relevant documents pertaining to age, educational qualification, employment record, experience etc. should accompany the application in envelop superscribed as "**APPLICATION FOR THE POST OF DIRECTOR OF HORTICULTURE & SOIL CONSERVATION, TRIPURA, AGARTALA**". However, the original documents should be produced at the time of interview.


- (d) The authority reserves the right to cancel the aforesaid Notice for re-employment at any time, without assigning any reason.
- (e) The selected candidate shall be allowed to draw fixed pay/ remuneration as per Finance Department Memo No. F. 8(4)-FIN(G)/88, dated, 29.08.2017 (copy attached).
- (f) The consolidated fixed remuneration/ honorarium + basic pension (before commutation) shall not exceed the last pay (basic pay) drawn before retirement in case a retired government servant is re-engaged on contract basis with a consolidated fixed pay/ honorarium.
- (g) The selected candidate may be given a Government accommodation, if available but license fee/ rent will have to be paid.
- (h) His/her leave etc. will be settled as per provision under relevant leave rules of the State Government of Tripura.
- (i) He/ She will be paid HTC/LTC as per State Government Rules.
- (j) The contract will be terminated by exercising one month's notice by either party.
- (k) All disputes are subject to the jurisdiction of Courts under West Tripura, Agartala.
- (l) Candidates shall have to provide their e-mail ID and contact number along with postal address so that they may be informed within a very short spell of time, if needed.
- (m) No T.A./ D.A. will be paid to the candidates for attending interview.
- (n) The Department will not be liable for any printing mistake.

MEMORANDUM

Subject:- Fixation of re-employment pay for the persons re-employed with a consolidated fixed pay/ honorarium on contract basis without any regular pay scale.

The State Government in the Finance Department vide Memorandum No.F. 8(4)-FIN (G)/88 dated November 05, 1999 and April, 12, 2002 and No. F.8(4)-FIN(G)/89 dated. 01. 11. 11 issued guidelines for fixation of re-employment pay of persons re-employed with a consolidated fixed pay/ honorarium on contract basis without any regular pay scale. Even after issue of the above guidelines, many proposals have been received by this department for issuing clarification regarding fixation of re-employment pay of persons re-employed on contract basis with a consolidated fixed pay/ honorarium.

2. Now, the Governor of Tripura is pleased to order that in supersession of all previous orders issued in this connection from time to time, the fixation of re-engagement remuneration of the persons re-engaged on contract basis with a consolidated fixed remuneration/ honorarium shall be made in the following manner:

- (i) They shall be allowed to draw fixed remuneration/ honorarium and not the scale/ pay band attached to the post. No protection of the pay enjoyed by such persons in their previous post/ assignment, if any, shall be admissible.
- (ii) The consolidated fixed remuneration/ honorarium + basic pension (before commutation) shall not exceed the last pay (basic pay) drawn before retirement in case a retired government servant is re-engaged on contract basis with a consolidated fixed pay/ honorarium.

Provided that if the pension of the employee got revised before or after joining on re-engagement in the State, the consolidated fixed pay/ honorarium will be worked out by taking notional basic pay (pay in pay band + grade pay) fixed in the revised pay scale/ pay band corresponding to the basic pay in pre-revised scale of the post held by him at the time of retirement minus revised pension before commutation from the date of actual benefit of revision granted to regular employee of State Government (i.e. 01.04.2017 or effective date of any subsequent revision of pay / pension of State Government Employee) .

Provided further that for the purpose of revision of remuneration of re-employment, no increment shall be considered while making notional fixation in the intervening period and subsequently.



- (iii) Remuneration of retired persons appointed on re-employment will be fixed as per formula as laid down in Finance Department's circular of even no. dated 12-04-2002 and No. F.8(4)-FIN(G)/89 dated. 01. 11. 11 upto 31.03.2017.
- (iv) The retired employee will continue to get pension and other allowances on the pension from the State/ Central Government or parent organization, as the case may be, in addition to the consolidated remuneration/ honorarium in the State.
- (v) When a person other than a retired government servant, who is in the regular scale of pay, is re-engaged on contract basis with a consolidated fixed pay/honorarium, his pay shall be fixed at the basic pay (pay in pay band+ grade pay) in the pay band corresponding to the minimum basic pay of the post to which he is now re-employed in the pre-revised pay scale.
- (vi) No other allowances, except TA /DA on official duty, will be admissible to the persons engaged on contract basis.

3. Henceforth, all retired employees will be re-employed/ re-engaged on contract basis with lumpsum remuneration.

4. This shall come into force with immediate effect.
