1. The Participants shall submit in **TWO PART SYSTEM** i.e. **Technical Bid** and **Financial Bid** separately in sealed covers superscripted as **Technical Bid** and **Financial Bid** clearly on the top of the each sealed covers both **Technical Bid** and **Financial Bid** labeled with offer for **D.N.I.E.O.I. NO. 42/EE(AGRI)/S/2018-19** as well as to whom and by whom offer is submitted.
2. The outer sealed cover in which the above two sealed covers are placed should be superscribed "**Construction of Rural Collection Center at B.C. Nagar under Bagafa Agri. Sub- Division under South Tripura District / S.H- Supply, installation and commissioning of Refrigeration system including providing and fitting – fixing of thermal insulation as well as insulated door in Pre – Cooling Chamber having size 3.625 m X 3.625 m X 3.33 m.**" and addressed to the Executive Engineer(Agri), Department of Agriculture & Farmers Welfare, Udaipur, Gomati .

TERMS & CONDITIONS

1. Every page of the terms and conditions and specifications of the bidding document should be signed , failing which the offer will be rejected summarily.
2. The rate shall have to be quoted clearly in the enclosed Schedule for Quoting Rate both in figures & words, otherwise offer shall not be considered as valid. Over writing or correction through any fluid or any measures will be treated as invalid offer.
4. (**Schedule for quoting rate should be detached from offer document and quoting rate duly filled in , it shall be submitted in Financial Bid which includes the Basic Price, packing, forwarding, transportation, handling charges, excise duty, insurance FOR delivery at the site and all Taxes, charges of erection and commissioning including live demonstration.**
5. **Earnest money will be 01 (One percent)% of quoted amount without ceiling limit on any Nationalized bank guaranteed by the Reserve Bank of India should be deposited in the shape of "Deposit at call" / "Demand Draft" Payable at Udaipur, Gomati District in favour of the Executive Engineer(Agri), Department of Agriculture & Farmers Welfare, Udaipur, Gomati District having validity not less than 6 (Six) months. The Earnest Money must be submitted along with the Technical Bid. Earnest Money in any other form will not be accepted.**
6. The Earnest Money of the successful bidder who refuses to undertake the contract after final selection shall be forfeited to the Government.

9. Sale Tax, any other taxes Duties, Royalties, Octroi etc. in respect of this contract as applicable, as notified by the Government from time to time shall be payable by the contractor and Govt. will not entertain any claim what so ever in this respect. Bidders shall note this at the time of quoting rates.
10. **If any component of installed refrigeration system in the cool chamber**, if not found up to satisfaction / standard or any other short coming shall have to be replaced by the agency at their own cost and risk within 10(ten) days from the receipt of the intimation during the guarantee / warranty period.
11. The quantity shown in the schedule of quoting rate is most tentative and may be increased or decreased from purchase schedule at the discretion of tendering authority. Successful bidder/ bidders shall have to accept any ordered quantity.
12. **If any Bidder withdraws his Bid before acceptance within the validity period, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 100% of the earnest money.**
13. If there is any additional information in respect of machineries/equipment etc , the bidder shall submit documents in technical bid.
14. The bidder should be solely responsible for the material/ machineries etc. in transit. Any legal interference of police / Sale Tax / Income Tax / Transport Dept. / any other Govt. agencies will be faced by the tenderer. The transportation delay / non availability of trains / trucks etc which never be considered by the authority as reason of delay to execute the work.
15. The Department will not take any responsibility regarding road permit. The bidder shall arrange road permit at his risk and cost for collecting any material, machineries etc. from outside of Tripura State.
16. The Taxes etc. as applicable as notified by the Government time to time will be deducted at source. The tenderer are requested to get themselves apprised before quoting Price.
17. The deduction of Taxes etc. at source as applicable shall be at the rate as notified by the Government from time to time.
18. Successful bidder shall have to give guarantee/warranty period against installed machinery/ materials etc. at least for 12 (twelve) months from the date of successful supply & commissioning and the execution of entrusted work should be completed within 15 (fifteen) days from the date of issuance of rate acceptance order.
19. Security deposit will be retained with the Department for 12 (twelve) months from the date of successful completion executed work.
20. The authority reserved the right to declare the bidding process as cancelled, at any time without any reason thereof.
21. Any unacceptable as well as evasive condition will not be accepted and will invite rejection of his/her /their offer.

24. 
