The Sealed tender are invited by the undersigned on behalf of the Government of Tripura from the bonafide, registered and experienced manufacturer or authorized distributors to Procurement of "**Chemicals**" for production of Bio-fertilizer at the State Bio-fertilizer Production Centre, Dutta Tila, under this establishment within 3PM of 23rd June 2021.

Name of the Item:-Chemicals for mass production of different strains of carrier based Bio-fertilizer, specially for Azotobactor, PSB (Bio-Phos).

Specification:-As per Annexure-I

Mode of Supply: - The supply of chemicals will be received in packed condition as per annexure-I at the State Bio-fertilizer Production Centre, Dutta Tilla, under this establishment.

TERMS & CONDITIONS

1. All the tenders are to be submitted with in stipulated Date and must be super scribed on the envelope /cover as "**Tender for supply of Chemicals at State Bio-fertilizer Production Centre ,Dutta Tila SARS**".

2. Tender shall be received **up to 3 P.M 23rd June 2021** on sealed cover and shall be addressed to the Joint Director of Agriculture (Res.), State Agriculture Research Station ,Arundhutinagar, Agartala and shall be opened on the same day at 3.30 P.M ,if possible.

3. The Rate shall be quoted clearly both in figures and words as per specification against each item mentioned in (Annexure-I).

4. Rate shall be quoted inclusive of all taxes.

5. **Technical Bid** and **Price Bid** are to be submitted separately in sealed cover- sealed envelope. "Technical Bid" should contain:

a) Earnest money deposit in appropriate shape.(If any company or Co-operative demand exemption of EMD, supporting valid documents along with the proposal must be submitted).

b) Complete specification of the material offered.

c) GST registration number and certificate.

d) Photocopy of PAN CARD.

e) Professional Tax Clearance Certificate.

f) Manufacturer authorization certificate.

g) All other documents , except price bid or rate quotation related papers ,shall be in the envelope of "**Technical Bid**".

Price Bid:-

The second sealed envelope should contain only price bid. The envelope should be clearly marked "Price bid" and also indicating tender no and due date. Both the envelopes as above should be put into an outer envelope and duly sealed and should be properly super scribed with the tender no and due date.

- 6). The supply should be completed within 15 days from the date of receipt of supply order.
7. Over Writing or use of correction fluid shall invite cancellation of tender papers.
8. Earnest money of Rs.5,000/- (Rupees Five thousand) only shall be deposited in the shape of "Deposit at call" on any Nationalized Bank and be placed in favour of Joint Director of Agriculture (Res), State Agriculture Research Station, Arundhutinagar, Agartala along with the tender without which the tender will not be treated as valid.
9. Each of the tenderer shall have to submitted up to date professional tax clearance certificate along with their tender, without which tender will be treated as invalid one.
10. The earnest money of successful tenderer who will refuse undertake the work shall be forfeited to the Govt.
11. The quantity as mentioned may increase or decrease as per requirement after finalization of the tender/rate etc.
12. The undersigned reserves the right to accept or reject tender in part or full without assigning any reason thereof.
13. The details technical specification of the Chemicals is given in Annexure-I.
14. The rate shall be valid for 1(one) year from date of acceptance.
