- 2. The outer sealed cover in which the offer is submitted should be super scribed as D.N.I.Q. for "Repairing & Maintenance of the Vehicle No. TR-01-D-0988(Mahindra Bolero) including painting etc." and addressed to the Executive Engineer(Mech), Department of Agriculture & Agriculture & Farmers Welfare, Matripalli, Badharghat, Agartala.
- 3. The rate shall have to be quoted clearly in the enclosed Schedule for Quoting Rate both in figures & words, otherwise offer shall not be considered as valid. Over writing or correction through any fluid or any measures will be treated as invalid offer. But correction with full signature of bidder will be treated as valid.

- 5.
