Subject: Filling up the post of Assistant Director by deputation at Central Agmark Laboratory (CAL), Nagpur in Directorate of Marketing and Inspection- regarding.

It is proposed to fill up one (01) post of Assistant Director in Level-10 of the pay matrix (Rs.56100-177500) at CAL, Nagpur in the Directorate of Marketing and Inspection, an attached office under Department of Agriculture and Farmers Welfare on deputation (including short-term contract) basis. Officers of Central or State Government or Union Territories or Autonomous or statutory organizations or Public Sector Undertakings or University or recognized Research Institutions are eligible:

- A. (i) Holding analogous post on regular basis; or
 - (ii) Holding post in Level 8 in pay matrix with two years regular service and
- B. Possessing the following educational qualification and experience:

Essential:

- (i) M.Sc. in Chemistry or Agricultural Chemistry or Biochemistry or Microbiology or Dairy Chemistry or Food Technology or Oil Technology or Toxicology or Biotechnology from a recognized University or equivalent with one year experience in the analysis of agricultural commodities and organic materials from Central or State Governments or Union territories or Autonomous or statutory organizations or Public Sector Undertakings or University or recognised Research Institutions or National Accreditation Board for Testing and Calibration Laboratories accredited Laboratory; or
- (ii) **B.Tech.** in Oil or Food or Chemical Technology from a recognised University or equivalent with two years' work experience in a supervisory capacity in analytical work of agricultural commodities and organic materials out of which one year should be in the analysis of agricultural commodities or organic materials from Central or State Governments or Union territories or Autonomous or statutory organizations or Public Sector Undertakings or University or recognised Research Institutions or National Accreditation Board for Testing and Calibration Laboratories accredited Laboratory.

Desirable: (i) Research experience in framing of standards for agricultural commodities.

(ii) Research experience in agricultural commodities and organic materials as evidenced by published work.

Note 1: The departmental Officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation and similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note2: Period of deputation (Including Short Term Contract) including period of deputation (Including Short Term Contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (Including Short Term Contract) shall not be exceeding 56 years as on the closing date of the receipt of application.

- 2. The officer selected on 'deputation' basis will have the option to draw his grade pay plus deputation (duty) allowance or to have his pay fixed in the scale of the post in accordance with DOP&T's OM No. 2-11/2017-Estt.(Pay-II) dated 24.11.2017.
- 3. Application (in duplicate) in the enclosed proforma alongwith the complete and up to date Annual Performance Appraisal Reports for the last 5 years (photocopies of the APARs to be got attested by an officer not below the rank of Under Secretary to the Government of India) and Integrity Certificate of eligible officers who could be spared in the event of their selection, may kindly be forwarded to Smt.
