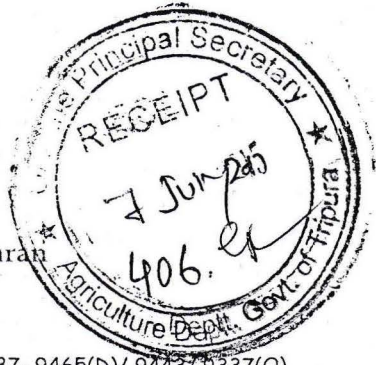

Sir/Madam,



Following the decision of the Central Government to fix the Minimum Support Price for TDN-3 (equivalent to TD-5) Grade of raw jute at Rs. 2700/- per quintal for the 2015-2016 season (July/June) and to reduce the number grades from the existing eight (TD-1 to TD-8) to five grades (TDN-1 to TDN-5) by merging TD-1 and TD-2 (TDN-1), TD-3 and TD-4 (TDN-2), TD-6 and TD-7 (TDN-4) and TD-8 will be TDN-5, the corresponding minimum support prices for all grades of jute and mesta all over India have been fixed by the Jute Commissioner.

Minimum support prices fixed for different varieties and grades of raw jute and mesta all over India for the 2015-2016 season are as follows:-
