

*Bonus of Rs. 75 per quintal, over and above the MSP, is also payable.

- The prices of other oilseeds belonging to the rapeseed / mustard group such as toria be fixed on the basis of their normal market price differentials with rapeseed / mustard.
- In the case of cereals, FCI and other designated State Agencies may continue to provide price support to the farmers, as in the past. FCI may continue to procure coarse grains even if they are not distributed under PDS.
 - Food Corporation of India (FCI) is designated as the Central Nodal Agency for procurement of pulses and oilseeds. To supplement the efforts of FCI, the National Agricultural Cooperative Marketing Federation of India Limited (NAFED), National Cooperative Consumers' Federation (NCCF), Central Warehousing Corporation (CWC) and Small Farmers Agri - Business Consortium (SFAC) may also undertake procurement of oilseeds and pulses as per their capacity. The losses, if any, incurred by the nodal agencies in such operations may be fully reimbursed by the Government of India.
