Dated 17-07-2020, applications are invited from the analogous post for engagement to **1(one) post of Executive Engineer(Mech)**, on deputation basis in the scale of Pay Rs.15600–39100, Grade Pay Rs.7100/ in the Level 18 of Tripura State Pay Matrix ,2018 under Department of Agriculture & Farmers Welfare. 
[A] Eligibility criteria of the candidate applying for the aforesaid post would be as follows:

- a) The recruitment will be made on deputation from analogous post of State Government/Central Government

[B] Terms and conditions for the aforesaid post would be as follows:

- a) The maximum age limit shall not exceed 56 years as on the date of closing for receipt of application.
- b) The application in plain paper must reach to the Directorate of Agriculture, Krishi Bhawan, Agartala-799001, West Tripura, on all working days w.e.f. **03-11-2021 to 12-11-2021** through proper channel.
- c) If any application is found incomplete or sent through e-mail or received after the cutoff date will not be considered. Further, the authority will not be responsible for any postal delay.
- d) Self attested photocopies of relevant documents pertaining to age, educational qualification, employment record, experience etc. should accompany the application in envelop superscribed as "**APPLICATION FOR 1(one) post Of EXECUTIVE ENGINEER (MECH)**, Department of Agriculture & Farmers Welfare." However, the original documents should be produced at the time of interview.
- e) While forwarding the applications, the appointing authorities must certify that there is no vigilance proceeding, pending or being contemplated, against the willing candidate.
- f) Incomplete application received without up-to-date ACRs/APRs for last 3(three) years and certificate of Integrity will not be considered.
- g) In the event of selection, the candidate will not be allowed to withdraw his/her candidature and will be relieved immediately by the concerned appointing authority.

- h) Period of deputation will be initially for 2(two) years which may be extended for another 1(one) year.
- i) Employee who are members of Tripura Government Employee Group Insurance Scheme shall continue to subscribe to the Group Insurance Scheme at the prescribed rates during the period of their deputation.
- j) The authority reserves the right to cancel the aforesaid Notice at any time, without assigning any reasons.
- k) All disputes are subject to the jurisdiction of Courts under West Tripura District, Agartala.
