2. The rates should be quoted both in figures and words clearly in the above mentioned format.
3. The Quoted rate should not exceed the reasonable present local market rate.
4. The Quotations should be submitted in sealed cover duly superscripted as "FLAG FOR SRI FIELD" to the Supdt. of Agriculture, Kakraban Agri. Sub-Division Udaipur Gomati District.
5. The relevant documents i.e Aadhar Card , Voter ID card , Ration Card , Xerox copy of Bank passbook , GST certificate as well as trade license of Shop if available etc. have to be produced along with the rate quotation.

6. Quotationers shall have to deposit an earnest money to an amount of Rs. 500/- in the shape of D-call in favour of Supdt. of Agriculture, Kakraban, Agri. Sub-Division, Udaipur, Gomati District, from any Nationalized Bank/Tripura Gramin Bank/Tripura State Co-Operative Bank and shall be submitted along with the sealed quotation. The said earnest money will be converted to Security money for successful bidder who would be offered the work. For others, the earnest money will be refunded.
