The Technical bid will be opened on same date at 4.00 pm (If possible) in the presence of tenderers, if any. Late Tenders beyond the scheduled date & time would not be accepted. : GENERAL TERMS AND CONDITIONS:

1. Earnest Money Deposit (EMD) & Tender Fee:

- a. Earnest Money Deposit (EMD) of Rs. 10000/- (Rupees ten thousand) Only and Tender Fee Rs. 1,000/- (Rupees One thousand) Only in the form of Demand Draft/D.Call in favour of Asstt. Director (DDO), Directorate of Agriculture, Govt. of Tripura on any Nationalized Bank/Scheduled Bank having branch at Agartala.
- b. EMD of L1 and L2 bidders will be retained by the Tender Inviting Authority (TIA). Other bidders EMD will be returned. EMD belonging to the L2 bidder will be returned after "Award of Contract" and EMD of L1 bidder will be retained as Performance security. Performance security money will be liable to be forfeited to the Government, in case of violation or breach of any of the terms of contract
- c. All the bidders shall have to deposit the EMD & Tender Fee compulsorily.

2. Signing of Agreement:

a. The successful tenderer shall have to execute an "AGREEMENT" with the Department of Agriculture for execution of work within 3 (Three) days from the date of issue of AOC (Award of Contract) in the Procurement Portal, failing which AOC (Award of Contract) shall automatically stand cancelled and earnest money of the tenderer will be forfeited to the Government Account.

3. Release of Payment:

- a) <u>No ADVANCE PAYMENT</u> shall be paid. Payment shall be made after submission of bills by the contractor subject to availability of fund.
- b) No escalation in rate on any account will be permitted during the contract period. Also, no subsidy will be given over the quoted rates.
- Payment will be made after submission of invoice with full signature based on availability of food.
- d) The contract will remain valid initially up to one year from the date of execution of the Deed of Agreement and may be extended for a period of further 12(twelve) months, if required. The extension of the validity of contract, if required by the Department of Agriculture & Farmers Welfare, will be binding on the Bidder.
- e) No interest can be claimed in case of delay in making payment beyond the stipulated period of payment.
- 4. The bidder should submit upto date 3 years IT returns of the agency/firm/company.
- The bidder should submit GST registration certificate, PAN/TAN card of the agency/firm/company.
- The bidder should submit valid Trade license of the agency/ firm/company from the appropriate authority of the State Tripura.
- 7. The bidder should be based at Agartala or a representative establishment at Agartala for supply of refreshment within a day notice.
- 8. The bidder should submit supply experience for last 3 (three) years in Government sector along with supporting documents.
- 9. The bidder should submit Annual Turnover of Rs.10.00 Lakhs in any of last three financial years with supported by documentary proof/ audited /CA certified statement of account.

- 10. The tender as well as the contract can be cancelled/terminated at any point of time by the Department without pervious notice and without assigning any reason, whatsoever.
- 11. If selected bidder fails to provide good quality food, his/her bills will not be settled by the authority.
- 12. The contract of the L1 bidder can be cancelled, in case quality food is not provided or supplied. In that case contract shall be awarded to the L2 bidder, if L2 bidder is agreeing to matchup rate with that of the L1 and will continue with similar pattern.
- 13. Sufficient Manpower and utensil for serving the food shall be provided by the bidder, as an when required.
- 14. If any of the certificates/documents furnished by the Bidder, found to be false / fabricated / bogus, the bidder will be liable to blacklisted.
