The sealed tender are invited by the undersigned On behalf of the Governor of Tripura from the bonafide, registered and experienced manufactures or authorized distributors or suppliers for Procurement of “**Chemicals**” for the **State Fertilizer Testing & Quality Control Laboratory, Dutta Tilla**, under this establishment within 3 PM of 20<sup>th</sup> July, 2020.

**Name of the Item;**-Chemicals for analysis of different fertilizer samples.

**Specification;**- As per Annexure -1.


**Mode of supply;**-The supply of chemicals will be received in packed condition as per Annexure ;-1 at the State Fertilizer Testing & Quality Control Laboratory under SARS.

**TERMS & CONDITIONS**

1. All the tenderers are to be submitted within stipulated date and must be super scribed on the envelop/cover as “**Tender for supply of chemicals for State Fertilizer Testing & Quality Control Laboratory, Dutta Tilla, SARS**”.
2. Tender shall be received **up to 3 P.M on 20<sup>th</sup> July 2020** on sealed cover and shall be addressed to the Joint Director of Agriculture (Research), State Agriculture Research Station, Arundhatinagar and shall be opened on the same day at **4 P.M**, if possible in presence of the Tenderer or their representative.
3. The rate shall be quoted clearly both in figures and words as per specification against each item (Annexure-I).
4. Rate shall be quoted inclusive of all taxes.
5. **Technical Bid** and **Financial Bid** are to be submitted separately in sealed cover. After detailed scrutiny of all the Technical Bid, valid tender shall be considered for opening of the Financial Bid.
6. Sealed envelope for “**Technical Bid**” should contain;
  - i. Earnest Money Deposit in appropriate shape.
  - ii. GST Registration No. and certificate.
  - iii. Complete specification of the material offered.
  - iv. Photocopy of PAN card,
  - v. All other documents, except price bid or rate quotation related papers, shall be in the shape of “Technical Bid”.
7. **Financial Bid:**

The second sealed envelope should contain only price bid. The envelope should be clearly marked as “**Financial Bid**” and also indicating Tender No. and Due Date. Both the envelopes as above should be put into an outer envelope and duly sealed and should be properly super scribed with the Tender No. and Due Date.
8. The rate shall be quoted inclusive all tax (GST etc.) both in figure and words.

9. The rate shall be quoted for every individual item separately to be supplied as per Annexure-I
10. Earnest money of Rs.2000/-(Rupees two thousand) only shall be deposited in the shape of "Deposit at Call" on any Nationalized Bank and be placed in favour of Joint Director of Agriculture (Research), State Agriculture Research Station, Arundhatinagar along with the tender without which the tender will not be treated as valid.
11. Each page of the tender documents shall be signed by the tenderers with the individual signature and seal with their quotations. If any erase with fluid or over writing found in the tender documents by any tenderers shall be treated as cancelled.
12. Rate quoted by the tenderers is final for the period of contact; no subsequent escalation of price will be acceptable.
12. The earnest money of the successful tenderers who refuse to undertake the contract after final selection shall be forfeited to the Government.
13. Each of the tenderer have to submit up to date professional tax clearance certificate along with the tender, without which tender will be treated as invalid one.
14. The earnest money will be retained for a period of 1(one) year from the date of completion of supply or the deviation of specification will also invite forfeiting of security money.
15. The supply should be completed within 15(fifteen) days from the date of issue of supply order.
16. Rate should be quoted inclusive of all taxes and packing, forwarding and freight charges, FOR at State Fertilizer Testing & Quality Control Laboratory, Arundhatinagar, Agartala.
17. The rate will be remain valid for 1(one) year from the date of acceptance of rate.
18. The undersigned reserves the right to accept or reject tender in part or full without assigning any reason thereof.
