Notice Inviting Tender

The sealed tenders are invited by the undersigned on behalf of the Governor of Tripura to procure "Soybean casin Powder (Digestion Medium) for State Bio-control Laboratory, Dutta Tilla, Agartala" under this establishment within 3 PM of 20<sup>th</sup> July 2020.

Name of the item :- Soybean casin Powder (Digestion Medium)

Specification:- Laboratory Grade, P<sup>H</sup> Neutral media.

Mode of Supply:-The supply materials will be received in Sealed container of 500 gm capacity at state Bio-control Laboratory, Dutta Tilla, under this establishment.

Terms & Conditions

1. All the tenders are to be submitted with in stipulated date and must be super scribed on the envelop/ cover as" Tender for Supply of 50 kg Soybean casin Powder (Digestion Medium) for State Liquid Bio-control Laboratory, Dutta Tilla, Agartala"
2. Tender shall be received up to 3P.M. on 20<sup>th</sup> July 2020, on sealed cover and shall be addressed to the Joint Director of Agriculture (Research), State Agriculture research Station, Arundhatinagar Agartala and shall be opened on the same day at 4 P.M. if possible.
3. Rate shall be quoted clearly both in figures and words as per 500 gm container mentioned in the specification against each container mentioned in Annexure-1.
4. Rate should be quoted inclusive of all taxes.
5. Technical Bid and Price Bid are to be submitted separately in sealed cover. After detailed scrutiny of all the Technical Bid, valid tender shall be considered for opening of the Price Bid.
6. Sealed envelope for "Technical Bid" should contain;
  - i. Earnest Money Deposit in appropriate shape.
  - ii. GST Registration No. and certificate.
  - iii. Complete specification of the material offered.
  - iv. Photocopy of PAN card,
  - v. All other documents, except price bid or rate quotation related papers, shall be in the shape of "Technical Bid".

7. Price Bid:


The second sealed envelope should contain only price bid. The envelope should be clearly marked as "Price Bid" and also indicating Tender No. and Due Date. Both the envelopes as above should be put into an outer envelope and duly sealed and should be properly super scribed with the Tender No. and Due Date.

8. The supply should be completed within 15(fifteen) days from the date of issue of supply order.
9. Over writing or use of correction fluid shall invite cancellation of tender papers.
10. Earnest money of Rs4000/ (Rupees Five Thousand) only shall be deposited in shape of "Deposit at call" on any Nationalized bank and be placed in favour of Joint Director of Agriculture(Research), State Agriculture Research Station, Arundhatinagar, Agartala, along with the tender, without which tender will be treated as invalid one.
11. Each of the Tenderer shall have to submit up-to date professional tax clearance certificate along with their tender, without which tender will be treated as invalid one.
12. The earnest money of successful Tenderer who will refuse to undertake the work shall be forfeited to the Govt.
13. The quantity as mentioned may increase or decrease as per requirement after finalization of the tender/rate etc.
14. The Undersigned reserved the right to accept or reject tender in part or full without assigning any reason thereof.
15. The detail technical specification of the materials is given in Annexure-1.
16. The rate shall be valid for 1(one) year from date of acceptance.
17. Rate to be quoted inclusive all taxes and F.O.R. State Bio-control Laboratory, Dutta Tilla, Agartala, inclusive of packing, forwarding and carrying etc. The supply materials will be received through gunny bags by weighing at above mentioned center.
