

- 5. Age Limit: The maximum age limit for appointment by deputation shall be not exceeding 56 (fifty six) years, as on the closing date of receipt of applications.

- 8. <u>Place of posting</u>:- CFQCTI, Faridabad and its regional laboratories at Navi Mumbai, Chennai and Kalyani.
- Note-1:- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.

Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

- Note-2:- Period of deputation (including short term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central government shall ordinarily not exceed three years.
- Note-3:- The maximum age limit for appointment by deputation (ISTC) shall not exceeding 56 years as on the closing date of receipt of applications.
- Note-4:- The crucial date of determining eligibility will be the last date for receipt of the applications.
